

“Perlico Freedom” and “Perlico Freedom Plus” Bundles Terms and Conditions

The following terms and conditions of the “Perlico Freedom” and “Perlico Freedom Plus” voice and broadband bundles are in addition to and form part of the terms and conditions of the Perlico Home Phone service and the terms and conditions of the Perlico Internet Service.

Residential Customers only. Perlico may provide a facility referred to as **“Perlico Freedom”** and **“Perlico Freedom Plus”** voice and broadband bundles to Perlico customers who avail of both a Perlico voice and a Perlico broadband facility whereby such customers may avail of discounted bundled rates on the rates payable on certain Perlico voice facilities and certain Perlico broadband facilities. The **“Perlico Freedom”** and **“Perlico Freedom Plus”** voice and broadband bundles to which they apply are set out in the Perlico Home Phone and Perlico Internet Terms, respectively available at www.perlico.com

Perlico may, at its absolute discretion, withdraw the **“Perlico Freedom”** and **“Perlico Freedom Plus”** voice and broadband bundles from any or all customers with 28 days notice.

To avail of a **“Perlico Freedom”** or **“Perlico Freedom Plus”** voice and broadband bundles it is a condition that:

1. The Bundle is only available to customers who avail of both the Perlico voice and Perlico broadband bundle package.
2. The usage of the Bundle is deemed to be an acceptance of the Perlico bundle terms and conditions.
3. In addition to these terms and conditions, the standard terms and conditions of the relevant Perlico Residential Home phone and Perlico Broadband packages apply.
4. The Bundle is subject to a minimum 12 month contract period. The contract period will be deemed to commence upon the successful provision of the voice component of the Bundle order.
5. In the instance where Broadband can not be activated on the customer’s line for network reasons the contract shall be null and void.
6. Where both components (voice and broadband) of the Bundle is ceased during the minimum contract period, Perlico reserves the right to charge the customer a termination charge of

€10.00 ex vat per month for the balance of the unexpired contract period and any other applicable fees which are out in the aforementioned standard terms and conditions of the relevant Perlico Residential Home phone and Perlico Broadband packages.

7. The Bundle shall automatically cease on a customer’s account if the customer ceases to avail of either component of the **“Perlico Freedom”** voice and Perlico Broadband Bundle or the **“Perlico Freedom Plus”** voice and broadband Bundle. In such event, the provisions as set out shall apply;

7.1 in the event the broadband component of the bundle is cancelled the customer can continue to avail of the Perlico voice package component hereafter known as **“Perlico New FreeTalk Anytime”** and the customer agrees to pay a monthly charge of €32.52 inc vat thereafter.

7.2 in the event the voice component of the bundle is cancelled the customer can continue to avail of the Perlico broadband package component hereafter known as **“Perlico 1MB Broadband Solo”** and the customer agrees to pay a monthly charge of €22.36 inc vat thereafter or **“Perlico 2MB Broadband Solo”** and the customer agrees to pay a monthly charge of €27.44 inc vat thereafter.

8. As part of the **“Perlico Freedom”**, **“Perlico Freedom Plus”** Bundles, **“Perlico 1MB Broadband Solo”** and **“Perlico 2MB Broadband Solo”** components cannot be sold separately at point of sale. **“Perlico 1MB Broadband Solo”** and **“Perlico 2MB Broadband Solo”** are components associated with the Broadband element of the Bundle when the Voice component is cancelled and cannot be sold separately at point of sale.

9. Subject to availability - existing customer in a Broadband contract may upgrade to the Bundle (excluding online orders) however this will require a new 12 month contract to begin from the commencement of the upgrade and excludes any special offers or sales promotions
