

“Perlico Pay As You Use Broadband” Terms and Conditions

The following terms and conditions of the “Perlico Pay As You Use Broadband” and “Perlico Home Phone Value” voice facility are in addition to and form part of the Perlico Internet Service terms and conditions and the Perlico Home Phone service terms and conditions.

Residential Customers only. Subject to availability Perlico may provide a facility referred to as “Perlico Pay As You Use Broadband” to Perlico customers who avail of the “Perlico Home Phone Value” voice service only. To avail of the “Perlico Pay As You Use Broadband” facility it is a condition that:

1. The facility is only available to new and existing residential customers who avail of the “Perlico Home Phone Value” voice service package.

2. In addition to these terms and conditions, the standard terms and conditions of the relevant “Perlico Home Phone Value” voice service facility shall apply.

3. The “Perlico Pay As You Use Broadband” facility is subject to a once off connection fee to which the customer agrees, and the service will be deemed to commence upon the successful provision of the order.

4. Minimum usage charge applicable of €2.55 inc vat for the first 250MB of usage, thereafter 1 cent per MB applies after the initial minimum usage charge. Usage is capped at €20.33 up to 10GB, thereafter standard excess usage charges apply for usage in excess of 10GB.

5. In the instance where the Broadband facility can not be activated on the customer’s line the facility shall be null and void.

6. Where both components (voice and broadband) is ceased during the minimum Perlico Home Phone Value” voice contract period, Perlico reserves the right to charge the customer a termination charge of €10.00 ex vat per month for the balance of the unexpired contract period and any other applicable fees which are set out in the aforementioned standard terms and conditions of the relevant Perlico Home phone and Perlico Internet Services.

7. The “Perlico Pay As You Use Broadband” facility shall automatically cease on a customer’s account if the customer ceases to avail of the “Perlico Home Phone Value” voice component.

In such event, the provisions as set out shall apply;

7.1 in the event the “Perlico Pay As You Use Broadband” component is cancelled the customer can continue to avail of the Perlico voice package component known as “Perlico Home Phone Value”.

7.2 in the event the “Perlico Home Phone Value” voice component is cancelled the customer can continue to avail of the Perlico broadband package component hereafter known as “Perlico 1MB Broadband Solo” and the customer agrees to pay a monthly charge of €22.36 thereafter.

8. Subject to availability - existing Perlico customers in a Perlico Voice or Perlico Voice and Broadband contract (excluding “Perlico Freedom Bundles”) may upgrade or downgrade to the “Perlico Pay As You Use Broadband” facility however this will require a new “Perlico Home Phone Value” 12 month minimum voice service contract to begin from the commencement of the upgrade or downgrade and excludes any special offers.

9. Perlico at its absolute discretion, reserves the right to suspend or cease the service and to amend and modify these terms and conditions, including prices in which the “Perlico Pay As You Use Broadband” service may be purchased, without notice for any legitimate commercial, technical or operational reason.
